#### 79/22TC Minutes of the Previous Meeting:

The minutes of the meeting 10<sup>th</sup> October were presented for approval. 66/22TC amendment to 'Resources & Governance' & Governance removed. It was unanimously resolved to accept the minutes of the meeting and the Chair signed the document.

## 80/22TC Minutes of the Previous Committee Meetings:

- a) The draft minutes of the Resources & Governance Committee held 31st October 2022 were noted.
- b) The draft minutes of the Planning & Development Committee held 28<sup>th</sup> September 2022 were noted.

#### 81/22TC County Councillor's Report:

County Councillor Richard Smith welcomed Katy Bailey as the new Town Clerk and also welcome Sharon Smith to the meeting.

- He commended Saxmundham Town Council for their organisation of the proclamation of King Charles III, the opening of the Memorial Garden & Remembrance Sunday
- He noted his visit to the Smile café at the Fromus Centre to join them for their anniversary; he
  was pleased to see that it was thriving.
- He noted that there was the desire for a new surgery in Saxmundham and that he had spoken to Dr Ed Garratt (CEO of NHS Suffolk & North East Essex Integrated Care Board) with regards to this. Although he couldn't say much he was optimistic that they were keen to move forward.
- Following the Autumn Statement, he noted that there would be more details to follow about a

County Deal for Suffolk. He also noted that there had been cross communication about the new elected Mayor to Suffolk.

- There were concerns about the budget for Suffolk, especially it's timing before Christmas. Balanced budget must be finalised by February and agreed by Full Council.
- It was noted that Suffolk have more energy projects than anywhere else in the country including Sealink and Eurolink but the County Council had some of the best planning staff in the country. It looked as if the link will be brought through between Aldeburgh and Thorpeness with a strong possibility of the sub station being built to the South of Saxmundham.
- Cllr. Hiley noted his concern for the elected Mayor being from a particular political party.
- Cllr. Jeremy Smith asked about the powers that the Mayor would have under the Government. County Cllr. Richard Smith noted that the position of Mayor works in urban areas but not in rural but felt that it would lead to extended funding and extended powers.
- Cllr. Hiley noted that he thought that Therese Coffey had originally opposed a sub station in land. County Cllr. Smith could neither confirm or deny whether that was the case.
- Cllr. Jeremy Smith said he was aware that there was a proposal that CIL money from the GNS will support expanded doctor's facilities and that this is detailed in the Neighbourhood Plan.
- There had been a meeting with UKPN & Sealink. Sealink were criticised for not properly researching the area around Walberswick.

#### 82/22TC **District Councillor's Report**:

District Councillor John Fisher noted that following a consultation there was the possibility of increase of pylons

- No report from Cllr S Gallant
- Stephen Baker is retiring at the end of the year and being replaced by Chris Bally as new CEO.
- East Suffolk Council were organising digital champions at Saxmundham library.

#### 83/22TC Chairs Report

The Chair commented on the following:

- Welcome Katy Bailey and Sharon Smith
- Remembrance Services had gone well but had lower attendance than expected
- There had been concern from High Street Shops about the road closure, however some shop owners had expressed that they would like the area to be pedestrianised.
- Kestrel Team were working in Saxmundham following the stabbing earlier in the week. It had been asked whether there was a link between stabbings.

#### 84/22TC Financial Matters:

a) Questions were asked about the projector and the clock. It was unanimously RESOLVED to note and ratify the payments and receipts for October 2022 for the Town Council, Gannon Rooms and the Market Hall.

Cllr. Lock updated that the field was now pretty much finished and thanked Amy, the Green Team and Charlotte for all their hard work. Bulb planting had been postponed until Saturday. Mulch to be placed in order to suppress weeds.

### 87/22TC Neighbourhood Plan

Cllr. Smith updated the following:

- There had been an appointment of an independent examiner who had visited Saxmundham and subsequently sent a list of questions.
- They noted that it was a well written plan but highlighted the issue of the boundary.
- There had been a meeting with the consultant Andrea Long, all responses to questions needed to be sent by 18/11/2022
- Boundary changes will need to go to the boundary commission
- District Council will also submit their responses

Councillor Jeremy Smith responses were unanimously approved

#### 88/22TC Energy Projects

- Preference to have the substation outside rather than Saxmundham
- It was questioned why the substation wasn't off shore
- Cables will probably be brought in either through Sizewell or Aldeburgh/ Thorpeness
- It was suggested that we collaborate with other parish councils
- Team to ask whether technical expertise was available

It was agreed that this matter would be discussed further at December meeting
