04/23R Minutes of the Previous Meeting

It was unanimously RESOLVED to approve the amended minutes of 8th December 2022 and the minutes of 19th December 2022 as true and accurate records.

05/23R Town Council

- a) It was unanimously RESOLVED to ratify the payments for January 2023.
- b) The Committee noted the receipts for January 2023.
- c) The Committee noted the bank balance of £37,481.61 at Unity Trust Bank and £160,092.06 at Cambridge Building Society as at 31st December 2022.
- d) The Committee accepted Cllr. Di Eastman's recommendation to approve the bank reconciliation as at 31st December 2022.
- e) The Committee noted the Trial Balance and the Income and Expenditure Report as at 25th January 2023.
- f) **It was unanimously RESOLVED** to recommend to the Town Council that the Trustees of the Market Hall are permitted to request financial support from the Town Council, when required during the financial year 20230-2024, to develop an events programme.

- b) The Committee approved the information to be made available in the Model Publication Scheme pursuant to the Freedom of Information Act 2000.
- c) The Committee noted the update of the previously agreed budget amounts to the Strategic Objectives for the financial year 2023-2024. The Committee asked for a short report on progress on Strategic Objectives actions for the financial year 2022-2023.
- d) The Committee noted the s.137 expenditure limit at £8.82 per elector for the financial year 2022-2023, the calculated limit, and the expenditure to date.
- **10/23R** It was unanimously RESOLVED to exclude the public under the Public Bodies (admission to meetings) Act 1960 on the grounds that publicity would be prejudicial to public interest by reasons of the confidential nature of the following business being transacted.

11/23R Possible Land Transfer

The Committee considered a possible transfer to the Council of land adjacent to 32 High Street. It was unanimously RESOLVED to, in principle, support the acquisition of the land subject to the satisfactory conclusion of legal, financial, maintenance, and public access rights' matters. It was further agreed to authorise Cllr. Jeremy Smith, in conjunction with the Officers, to liaise further with the landowners and for the Town Council to contribute a reasonable financial amount towards legal expenses.
