### **Discussion:**

- The Clerk informed the Committee that the traffic survey will be completed later in May due to scheduled road closures.
- The Committee discussed the design quote received from Suffolk County Council of £4458.06. This quote includes:
  - Site visits
  - Preparation of scheme drawings,
  - Consultations with third parties
  - Obtaining approval from third parties
  - Construction cost estimate
  - Hazard identification and risk assessments
  - Utilities enquiries
  - Overhead cable assessments (if required)
  - o Temporary traffic management plans
  - Compiling the works pack, (ready for ordering works element of the scheme).

Councillors decided that they wished to proceed with the designs but were concerned that the County Council envisaged that the works element would cost in the region of £42,000.

• The Clerk informed the Committee that 4 volunteers had put themselves forward for speed watch and the Committee agreed to proceed with setting up the scheme.
