Street Furniture

- a) The Committee considered a quotation to replace the sign at the skate park as recommended in the recent RoSPA report. It was **unanimously resolved** to proceed with the quote, following verification that the text on the sign does not need to be changed and that the post is secure.
- b) The Committee agreed to supply and fit a litter bin at the junction of Fairfield Road and Revell's Terrace, following confirmation of the location with the resident who requested a bin.

Memorial Field

- a) The Committee considered a quotation for the installation of a roundel in the Memorial Garden. The Deputy Town Clerk informed the Committee that the donor of funds for the roundel had rejected the proposed design. It was **unanimously resolved** to ask the contractor to review the design and to approach another contractor for a quotation.
- b) The Committee considered a quotation to create a circular path within the Memorial Field. The Town Clerk advised the Committee that she had since recognised that the project needs a clear brief with a detailed specification to enable contractors to provide accurate quotations, to support grant applications, and to inform Town Council decision making. It was **unanimously resolved** to draft a project brief following a site visit by the Committee.
